Percentage rate Tenders under single Bid system are invited on behalf of the KTDFC for the following work from the eligible Contractors

1. The bidder must have experience in the specialized repair works on multistoried buildings such as (i) external strengthening of RC beams and slabs using carbon fiber fabric composites and CFRP pultruded sheets, (ii) strengthening of RC columns externally using carbon fiber fabric composites and CFRP pultruded rebars by near surface mounted (NSM) technique, (iii) concrete jacketing of RC slabs using microconcrete and (iv) soil stabilization around the piles by open end grouting technique.
2. The bidder must have work completion certificates from State Governments/Central Government/Public Sector Undertaking firms on the specialized repair works mentioned in item No. 1

1. Information and Instructions for bidders posted on website shall form bid document.

5. Certificate of Financial Turnover: At the time of submission of bid, contractor may upload Affidavit/Certificate from Chartered Accountant mentioning Financial Turnover of last three years or for

the period specified in the bid document and further details if required may be asked from the contractor after opening of the tender. There is no need to upload entire voluminous balance sheet.

6. The bid shall be opened online on due date mentioned above. The time and date of opening of financial bid of contractors qualifying as per the above has been as declared in this NIT.
7. Tender documents can be downloaded from the website of KTDFC for work. The cost of Tender document is to be paid.
8. KTDFC will enter into negotiations with the Lowest Tenderer if so desires.

Completed Tenders containing price bid also shall be submitted Online and are received only on website [www.ktdfc.com](http://www.ktdfc.com) at the Office of the Chairman & Managing Director, KTDFC, Trivandrum at the time fixed and the date indicated in the NIT. The Tenderer will be at liberty to be present either in person or through an authorized representative at the time of opening of the Bid with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end. Bids of only those tenders who are eligible/qualify as per the above shall be opened, at the time and place as per this NIT.
